1 st CMAS Freshwater Spearfishing European Championship 2022 11th – 15th of August 2022, Lake Puruvesi, Finland.

1. Organization and Control

- CMAS (World Confederation of Underwater Activities) has entrusted Sukeltaja ry (Finnish Divers Federation) with the organization of the “1 European Fresh Waters Spearfishing Championship”, which will take place in Puruvesi, Punkaharju, on the beautiful lake side of Finland, from 11 to 15th August 2021.
- Finnish Divers’ Federation has the pleasure of inviting your National Spearfishing Team including, women and men categories, to the 1st CMAS Freshwater Spearfishing European Championship.
- Punkaharju lies 350 km northeast of Helsinki. There is a train connection from Helsinki to Punkaharju, which takes approximately four hours. You can take train straight from the Helsinki Airport. So, it is not necessary to rent a car.
- The Competition will take place on Saturday, 13th and Sunday 14th August 2022. Enrollment day is the 11th August and the closing Gala dinner will take place on the 14th August 2022. Departure for home on the 15th August 2022.
- The Competition has separate categories for men and women. One athlete per boat. The competition areas are the same for male and female competition.
- Due to challenges in supply of competition boats, the competition is limited to 10 participating countries from Europe. Including both men and women teams per country.

COMPETITION COMMITTEE:

It is a body consisting of the CMAS Technical Delegate, appointed by the CMAS Board of Directors on the proposal of the Spearfishing Commission, 3 non-competing team captains

chosen from among the participants in the technical meeting as consultants and 2 reserves of the team captains, who are also appointed during the technical meeting.

Technical control-related tasks will be discharged by the:

- CMAS Technical Delegate: to be appointed by Cmas
- Competition Director; to be appointed by organizer Federation
- Main secretary of the organising committee: Antti Olin
- Responsible for technical and safety matters;
- Medical service coordinator;
- Boat Commissioners;
- Responsible for Weighing and Classification.
- Judge in charge of protocol and ceremonies.

The International Jury, composed by Cmas Technical Delegate and having advice of Competition Committee under request, has the independence and responsibility to take any decision to implement Particular Rules, Cmas General Rules or facing circumstances not regulated in such regulatory framework.

Local assistance services (valid for both the Men's and Women's European Championship):

- Two ambulances stationed on land equipped each with personnel experienced in first aid procedures;
- A doctor in port and two doctors at sea, on board of the boats for safety;
- Advanced CPR Procedure;
- Boats for safety: one for every ten participants;
- Safety divers ready to act;
- Savonlinna Central Hospital (it's 25 km away from Savonlinna);
- Hyperbaric chamber at Turku (it's 350 km away from Punkaharju);
- Helicopter rescue; Ilmari at Kuopio/Joroinen

2. Registration

- We kindly ask you to send us and CMAS HQ the initial entry form (Annex 1) by 31st December 2021. We would appreciate you communicating us as soon as possible, if you intend to participate. This will help us a lot in organizing this new event. The final registration form (Annex 2) and the inscription form (Annex 3) need to be sent by 15th March 2022. No registration is accepted after this date to the Championship.
- **Non-European Federations:** If possible from the point of view of the logistics, non-European federations affiliated to CMAS Spearfishing commission can be included in the event in order to get acquainted with the new form of championship. They will naturally then be part of the event outside the official European Championship. After registering, your Team will receive all the necessary information about the competition, including detailed competition rules, accommodation information and scouting opportunities.
- **CMAS registration fee needs** to be paid to the CMAS via the CMAS database by the date given by CMAS and all athletes need to have a valid CMAS licence and an insurance that covers participating in this event.
- **Team entry fees:** The following table contains all the different inscription options. Mode 1 and Mode 2 include boats with fuel for competition days for team members 1-3. Team members 4-6 are substitute and other delegates.

- The above options include participation to the Gala Dinner, organized after the competition, for all inscribed members of the team. Accommodation during 11.-15.8. with breakfast is included in the Mode 1. Fuel for the boats during the competition days is included in the Mode 1 and Mode 2. There are different size of cabins and organizers will find the most suitable ones according to the size of the delegation.
- All payments shall be paid by bank transfer, clearly marked "Freshwater Spearfishing EC2022" and name of the Team.

- 50% of the payment needs to be done by 15th March and the remaining 50% of the fee by 15th June 2022.
- In addition to the costs outlined above, all athletes must be in possession of an individual sport license and each federation will need to pay the federation fee directly to CMAS, Rome. The required forms for these payments are available on CMAS website cmas@cmas.org
- OPTIONAL costs
 - Accommodation for extra days at Harjun Portti Holiday Resort: There are different size of cabins mostly for 2 or 4 person. Price per cabin between 100-140€ per night (Individual cost in double Room around 50€)
 - Daily meals. There is a supermarket in Harjun Portti, and the cottages are equipped with kitchen. It will be very convenient for the teams to prepare their own meals there according to their own wishes in their own time schedule. There are also restaurants in Harjun Portti and walking distance.
 - Harjun Portti Holiday Resort Café-Restaurant serves lunch daily 11-15
 - Boats for scouting: Teams can reserve boats for scouting from the organizers or from Harjun Portti resort directly. All scouting boats are privately own and prices differ according to boat and engine size between 80-200€ per day + fuel.
 - Fuel for the scouting boats. Fuel station at Harjun Portti resort

We will arrange transportation from Harjun Portti Holiday Resort to and from the Gala Dinner.

3. Points Calculation and Valid Catches




- **The point calculation will be done in two phases:**

Phase 1 Classic Points

- in groups I, II, III, IV and V scoring is done by attributing one (1) point per gram of each valid fish. For the fishes in groups I, II, III, IV and V, the maximum amount of points for weight is **12.500** points per single fish. All fishes belonging to same group are weighed together
- For the “Biggest fish” trophy only valid fish from groups I, II, III, IV and V will qualify. The trophy will be awarded to the competitor who catches the heaviest fish.
- There are three types of bonus points applied:
 - The bonus for each valid catch is a # of points = minimum weight
 - There will be an extra bonus per different species = 300 points X # species
 - Bonus for completing quota of catches of species = 1000 points X quota completed
- Penalty will be applied for fish weighing less than 2/3 of the specific minimum weight. Penalty points are equal to the minimum weight grams of the species.

- **Valid Fish:** Only valid fish from the groups listed below I.-V. will be awarded any points



Phase 2: qualification points

The individual qualification points are calculated per day as:

(competitors points total / 1st competitor points total) x 100, or each category MEN – WOMEN

European Championship final Classification

Individual classification MEN-WOMEN: It will be determined by the sum of the two days punctuation and it will be expressed on percentage. In case of punctuation draw it will count the higher number of valid captures, if equality is maintained it will count the biggest capture.

Nation Teams classification MEN-WOMEN: It will be determined by the sum of the two days punctuations of every nation competitor and it will be determined on percentage.

4. Competition

- i. The Base Port will be in the Harjunportti Resort.
- ii. Competition time is 6 hours per day. (Water temperature during the competition time in Lake Puruvesi is warm +18 to +22 celcius)
- iii. Only the International Judge or the Competition Director may decide, by mutual agreement, any change in the competition areas if necessary. In case of disagreement the CMAS International Judge will take a decision.
- iv. A count of participants and confirmation will be made before leaving the harbor to competition area. All boats must follow the Competition Director boat back and forth the competition area.
- v. Once arrived at the competition area, there will be a new recount of participants and the time for starting and finishing the fishing event will be communicated. The meeting point and the margins of time to pass the control once the fishing time expired will also be communicated at that moment.
- vi. Only in the event of adverse meteorological (whether or sea) conditions, the Security coordinator can ask for authorization previously to the CMAS Technical Delegate to decide the partial/total cancellation of the fishing event in one day and/or category. The CMAS Technical Delegate has total autonomy and responsibility for canceling totally or partially any fishing event, for any organizational issue or due to weather conditions, even reducing the time or the fishing area.
- vii. If the competition had to be cancelled owing to circumstances beyond our control or adverse meteorological conditions, the championship day will be considered valid if the time passed since the beginning is at least two thirds (2/3) of the duration planned for that day of competition (4 hours). In the case of one valid day completed, the Championship will be validated. The beginning and the ending of every fishing event will be communicated by radio or mobile phones. The boatmen/commissioners will inform about the ending to their fishermen. The fishermen must get on board when informed about the ending.

5. Competition areas A and B and the gps points:

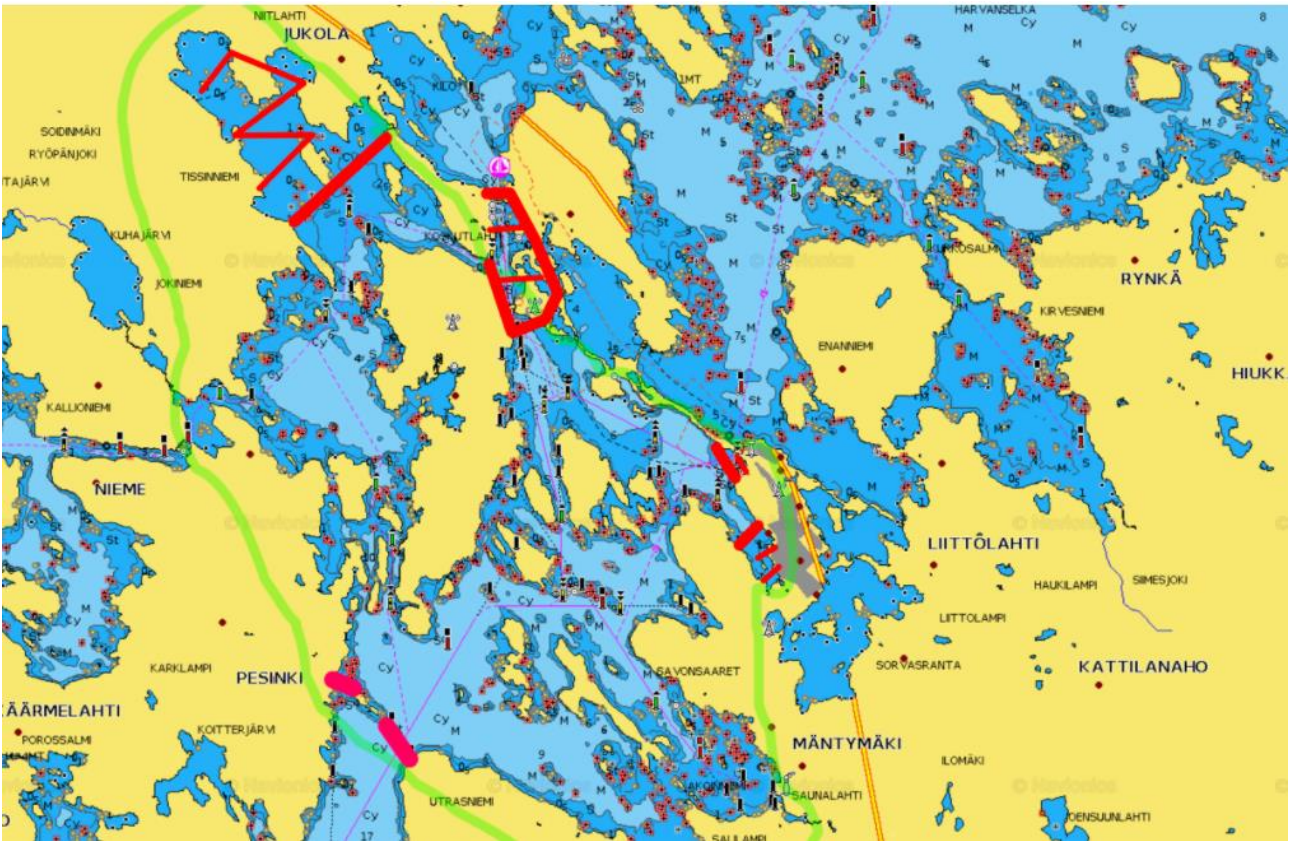
Area A

NOTE1: GPS points mark the area only partly as natural borders as small islands give the exact border. There is no reserve zone as both of the areas hold plenty of islands to give cover in case of a bad weather.

NOTE2: All wrecks in the area are protected by Finnish law and must be approached cautiously; do not move any items from wrecks nor make any damage

NOTE3: There are many shallow areas with under water rocks. It is the boat driver's decision to choose the route to wanted location

NOTE4: There is some Nature reserve zones which are clearly marked in the area with gps points.

NOTE5: Keep minimum 100 meters distance from the summer cottage "docks"

NOTE6: Keep the 25 meters distance to any fishing nets.

6. Boats

The SUKELTAJA ry (championship organizer) will supply official boats if required. Boats will be given by drawing. The participants who bring their own boats can use them in the competition. In case of breakdown, the boat will be replaced as soon as possible. Complaints about the substitute boat will not be accepted.

7. Allowed Equipment

- Only allowed to use the following equipment: one or more spear guns of rubber bands or compressed air, using athlete's muscular effort. Fins, masks, snorkels, torches, weight belt, spears and hooks, knives, neoprene wetsuit, gloves and dive computer, GPS, fishing sonar, radio transmitters, mobile phones and a complimentary official buoy with the register number (10 litres minimum) Diver's recovery vest, variable weights.
- It is forbidden:
 - Carrying fish in the belt or any other place than the buoy or the boat.
 - Have loaded speargun on board.
 - Have loaded spear gun hung on buoys.
 - To take any fish from the nets or take the dead fish. All fish will be check during the fish weighing.

8. Lake Puruvesi Legal Requirements for Training Sessions. Statement of Liability.

- Participation in the Fresh Water European Championships takes place at athletes' own responsibility. The hosting federation is not liable for personal or material damage.

- Teams that fish or simply dive in Finland waters during the training sessions (any time before the competition) must apply to organizers (SUKELTAJA ry) for a Federative fishing license. The federation fishing license (1 week) is included in the registration fee. But it is each team's responsibility to ask the official documents before starting training sessions. These formalities are necessary even fishing is not practiced during the training sessions. Spearguns are allowed in the boats if after or before the scouting the teams wish to go fishing outside of the competition areas. In Finland you have to stay away 25 meters distance from any fishing nets and 100 meters from private docks or houses in the coast line. Each boat must have visible minimum 50x50cm blue and white diver flag on the boat.



- Organization is not responsible for any inconvenience caused by Coast Guard or authorities controls if competitors do not obey the existing Finland's legislation.
- 14 days before the competition session inside of the competition zones it is forbidden to train or do examining activities using spear guns, scuba diving breathers or underwater scooters.
- Competition areas will be closed the day before the competition session (11.8 Thursday 21 pm) and it is totally forbidden to go inside of the competition areas during the Friday 12.8
- During the competition the Commissioners are supervising the participants to keep the Law.
- The organization will pay the spearfishing license for all teams, for specific practicing areas that can be used for shooting fish before the competition (scouting days). A map of these areas will be given to teams together with the fishing license when teams arrive. Using speargun is only allowed in these specific areas.

9. Discipline

Every member from the registered teams is expected to know and respect the competition regulations. Judges and commissioners have the right to intervene in case of breaking the regulations.

Judges and commissioners can announce warnings or inform for later disqualification by the CMAS Technical Delegate.

Judge-Commissioners must notice the competitor his/her infraction once committed and when turning official, the Judge-Commissioners must inform the CMAS Technical Delegate, the one who decides the sanction.

A number of competitors behaviors or infringements are motive for a WARNING, a Disqualification in the Day or a Disqualification in the Championship.

The competitor who is totally disqualified from the competition loses all rights to the classification in the Competition.

Infringements punishable with warning

- i. To arrive late at the control points planned by the Organization, except for security reasons.
- ii. For incorrect behavior towards other competitors or the Judges.
- iii. To move away more than 25 meters from the official buoy.
- iv. To load or to maintain the spear gun in a loaded state on shore, on the buoy, the fishing board or on the support boat.
- v. To have a buoy not in conformity with the Rules.
- vi. To not declare to have caught the total number allowed for a certain species of fish, as stated in the Particular Rules.
- vii. During the time of competition, to be/dive out of the limits of the competition zone up to a distance where this could be considered as accidental and not intentional.
- viii. To have obtained help to recover the official buoy from anyone on board of own boat, during the time the competitor is diving or in surface (no warning for any help when competitor is on board of own boat).
- ix. To present for weighing a fish speared by another competitor and left at the surface or at the bottom with evident signalization or a fish that was brought to the surface after the lapse of the competition time. The fish will not count and will be invalid.
- x. To present the catch in a bag with or without water, different than the one provided by the organization. Apart from the warning, the catch will be weighed at the end of the weighing after removal of the bag and the water.
- xi. To violate any other provision in the rules not specifically provided for in this article.

Punishable Infringements with disqualification for the day

- i. Two warnings, in the same competition, will be immediate disqualification for the day.
- ii. Carrying fish at the belt or keeping catches at any place out of boat or official buoy.
- iii. During the time of competition, go out of the limits of the competition zone beyond a distance where this is considered as intentional.
- iv. To be in the Competition Zone before the Official start signal, leave the competition zone before the end of the day of competition or without passing check control of arrival, without getting permission of CMAS Technical Delegate or Director of Championship, through Boat Commissioner request.
- v. To stay in the sea (lake) after the official time of the end of the competition, ignoring the prompts about end of time from Boat Commissioner.
- vi. To be dragged by boat in the water under any circumstance except emergency or safety reasons.
- vii. To use the Freediver Recovery Vest without previous notification of the CMAS Technical Delegate and initialing of its gas capsule..
- viii. To inflate the Freediver Recovery Vest (even if by accident) or not to present its gas capsule for inspection after the end of each competition day..
- ix. To use use electric winch or other electric device to lift the weight from the bottom.
- x. To use gps/motor (Minn Kota) machine that keeps boat at the same spot (electric anchor).

Punishable Infringements with total disqualification (Deleted from official classification):

- i. Aggression towards other Competitors, the Judges or the Members of the Organization before or during the competition.

- ii. To fish species prohibited by the National Legislation, specified by the Organizing Country or to infringe any fishing local law.
- iii. To replace the catches of the regulated species or exchange them between athletes..
- iv. To use any type of scuba diving or breathing apparatus.
- v. To be (diving or cruising) in the Competition Zone, with or without speargun, before the Official start time in the days of competition.
- vi. To return or leave in water catches of any kind / category: not valid, forbidden or valid species of any weight.
- vii. Weighing fraud.
- viii. Use of exploding tips, luparas, and / or any gadget with explosive power or any system which is not charged by human physical effort.
- ix. During official time of competition as well as along the official period of zone visit before use any diving breathing system, use of submarine propeller gadgets as "torpedo".

10.Complaints

- i. Each participating team has the right to place any complaint to the International Jury.
- ii. Only the captain of the team will sign and present a complaint.
- iii. Any complaint will have to be accompanied by a guarantee; the amount is fixed by the CMAS.
- iv. A complaint must be presented in writing to the CMAS Technical Delegate, in French, English or Spanish:
 - Before the weighing, for those regarding the competition.
 - During the weighing, for those regarding the weighing and concerning the weighing itself
 - With regard to an error in the classification, the presentation for a complaint must be made to the CMAS Technical Delegate within 15 minutes following the publication of the classification and accompanied by the payment of the necessary financial guarantee (this procedure will cause immediate delay in the protocol ceremony for the medals delivery).
- v. The time to prepare and present a complaint. The Captain will have a 30 minutes deadline to write and present his report to the CMAS Technical Delegate. Failure to meet the deadline the complaint will be regarded as not valid with the loss of the guarantee.
- vi. The complaint will be declared inadmissible if all these conditions are not met
- vii. If the complaint is accepted the guarantee in cash will be refunded. If not accepted, the guarantee in cash remains with the CMAS. If, however, during the hearing of the complaint, the Technical Delegate establishes that the complaint was wilfully fraudulent in order to signal an innocent athlete to be punished or disqualified being the purpose of the country the captain of which made the complaint to gain fraudulent advantage, the Technical Delegate may at his discretion impose a penalty of 20 percentage points to the athlete and/ or 60 percentage points to the team from their end result depending on if the fraud lay with the athlete or with the captain of the country that filed the complaint. If the country is penalised, the 60 percentage points will only be subtracted from the nations' classification.

11. Regulatory Control

- The CMAS Technical Delegate In the CMAS Championship: the CMAS Technical Delegate is elected by the Cmas Spear Fishing Commission and approved by the CMAS Board of Directors. He has full Powers and authority on judges, commissioners and organization staff until the publication of the official results. He must approve their election and give them instructions about the competition specific regulations. The CMAS Technical Delegate's objectives are:
 - a) Inspection of competition facilities.
 - b) Boats commissioners and boats drawing.
 - c) Confirming and signing the classification before the publication.
- The CMAS Technical Delegate must apply the Regulation and the CMAS decisions and resolve all emerging doubts, which are not included in the Regulation. He must check that all the commissioners are in their position and appoint substitutes or remove the incompetent ones. He can also appoint new officials if necessary.
- The CMAS Technical Delegate gives the starting signal once the Judge members (commissioners, organization and security members) are in their positions and ready. The CMAS Technical Delegate can cancel the competition without consulting it with the competition director or the organization:
 - On any adverse meteorological circumstance or security reasons (after consulting with the security coordinator).
 - If competition areas or facilities do not fulfill regulation requirements.
- The CMAS Technical Delegate, functioning as International Jury, will be assisted (if required) by a Competition Committee formed by 3 team Captains (who do not compete) appointed by the CMAS Technical Delegate.
- The functions and responsibilities of the Competition Committee are providing advice and supporting the International Judge whenever is required. The committee will not take a decision except in case of the CMAS Technical Delegate's injury or inability.

12. Rules interpretation

- In all circumstances not included in this specific regulation, the CMAS International General Rules for spearfishing competitions will be applied.
- If none of Particular Rules or Cmas International Rules regulate some arising circumstance, the Cmas Technical Delegate will take his own decision.

13. Anti-Doping Control

According to the Finnish Anti-doping Agency, the control might be made whenever during the Championship.

14. Responsibilities

The World UnderWater Activities Confederation CMAS, the Organization Federation, the Cmas Technical Delegate, Competition Director, the Commissioners and all related members will not held responsible for accidents or equipment lost that may occur before, during and after the championship to participant or third parties.
